Each building lot includes the structure and setbacks. Parking is shared across the site. The empty space accommodates roads, stormwater, and common areas.

Site: 2.3 ac — Building lots: 0.2 ac (11%) — Parking, roads & infrastructure: 2.0 ac (89%)

The remaining 89% accommodates shared parking, internal roads, stormwater management, landscaping, and utility easements. Industry standard allocates 25–35% of gross acreage to building lots. This plan is at 11%, which is within the comfortable range and leaves room for amenities or additional units.

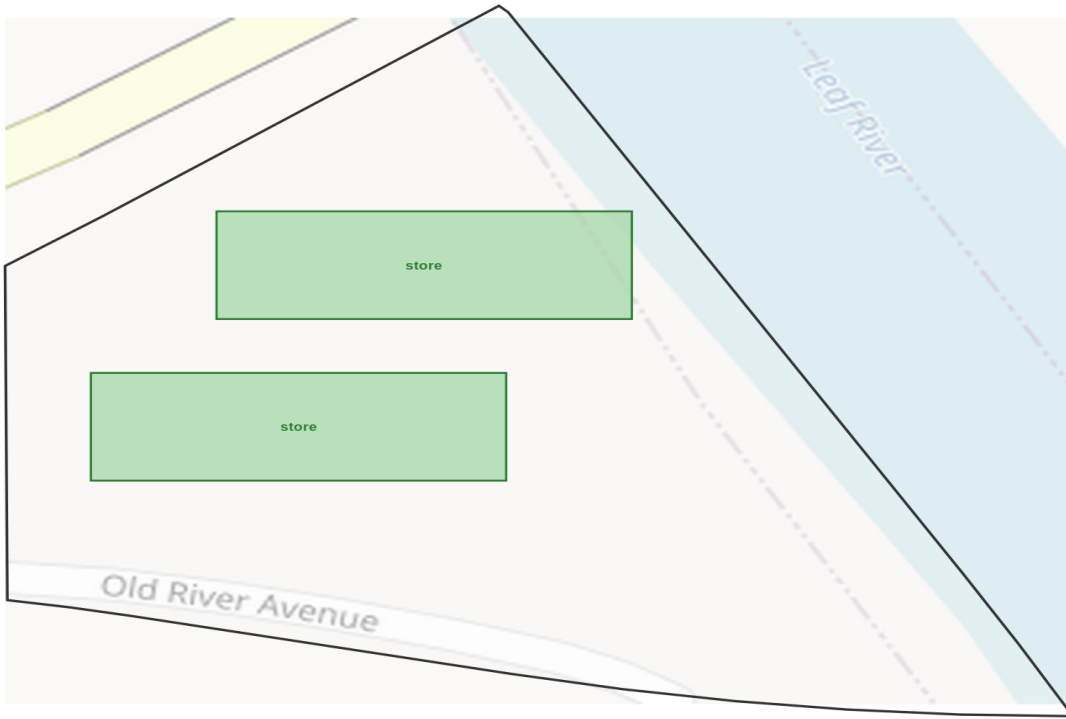

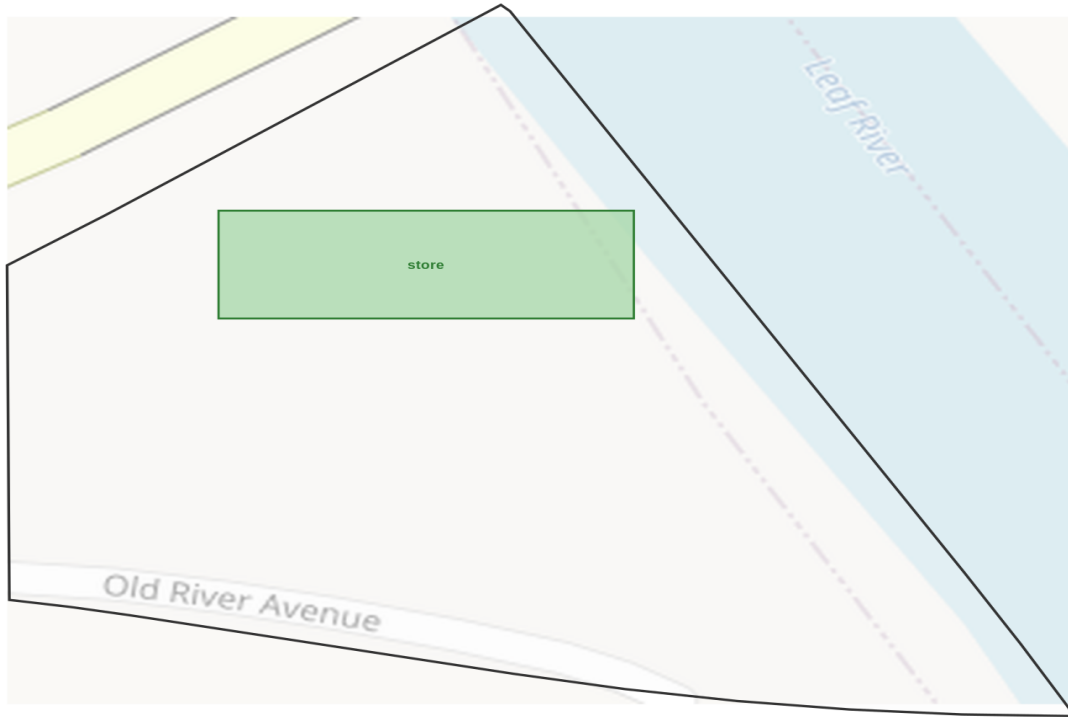

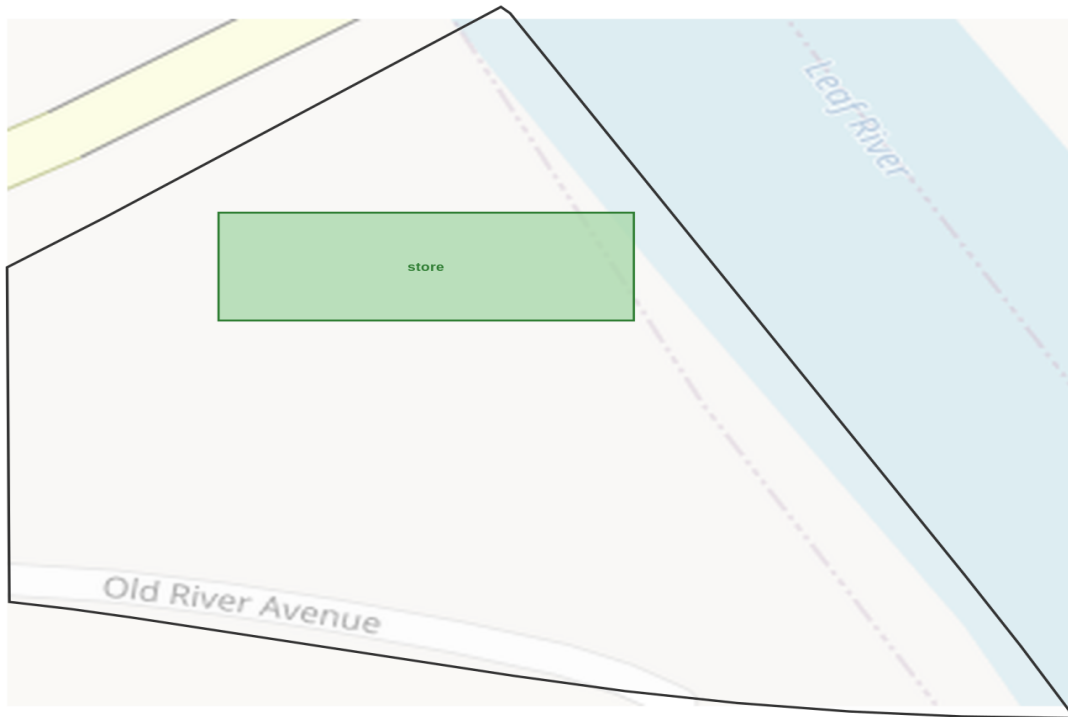
